**I further report that** during the audit period, there were no instances of:





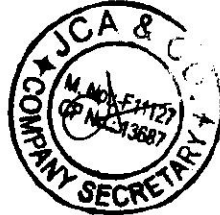
My report of even date is to be read along with this letter.
